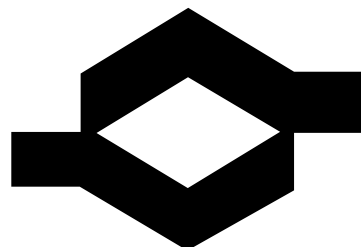

REGULATIONS

1

The 'Application for selection' is valid only if completed and signed, and sent to the following address:

'theyoungdesignersfair' has a limited number of spaces available. Entering an 'Application for selection' does not mean automatic selection to participate. A selection committee convened by the Interieur Foundation will decide who will be allowed to take part, mainly on the basis of the documentation provided alongside the 'Application for selection'. The members of the committee will remain anonymous, and their decisions are final.

Selected designers must pay a stand rental fee of €1,000 (+21% VAT) before September 1st 2010 on the account of the Interieur Foundation:

A stand can only be allocated after receipt of the fee before the deadline. Should a participant decide not to take part after payment of the fee, it cannot be refunded and will be regarded as compensation.

Only designers at the start of their career, who have not been active designers or members of a design collective for more than 5 years maximum on INTERIEUR 2010 opening date, may take part at 'theyoungdesignersfair'.

Manufacturers, retailers or distributors may not participate. However, participating designers may show products that have been taken into production. Participants may obtain sponsorship from companies whose products

are displayed on the stand. In such cases, the visual presence of manufacturers or sponsors should remain limited to simple mention of their name on the stand, and brochures which include only the selected products. Before the start of 'theyoungdesignersfair', the committee will publish detailed instructions in order to guarantee as much uniformity as possible, and will be the sole authority as to what will be allowed. Exhibitors must remove any advertising material that does not conform to the rules without delay.

To ensure as much variation and balance as possible, the Interieur Foundation will decide the exact stand to be allocated to participants.

7

The Interieur Foundation undertakes to make available to each exhibitor a fully equipped stand, including the necessary basic lighting. Each stand will measure 4x4m. A detailed architectural plan will be sent to participants before September 1st 2010 at the latest. Participants must be aware, however, that it will only be possible in principle to place loose objects within the stand space, without making fundamental changes to the stand design. Exceptions will only be allowed after consultation with the Interieur Foundation.

Work on dressing the stand can start two days before the opening of INTERIEUR 2010. All stands must be finished the day before the opening, before 5pm. Breakdown may not start before the Biennale is closed, and may take place two calendar days after the exhibition. Remaining packaging and other materials will be removed by the Interieur Foundation if necessary, removal costs to be charged to the exhibitor. Each participant is responsible for transport plus cost of all items on display and other material, before build-up and after breakdown.

The venue will be equipped with under-floor cabling for electricity, onto which participants can connect their own installations. Participants must advise the Interieur Foundation about each connection to this network before September 1st 2010, including a detailed description of power requirements.

Signage at 'theyoungdesignersfair' will be installed exclusively by the Interieur Foundation, to ensure conformity.

11

Each participant is responsible for the permanent manning of his/her stand. 'theyoungdesignersfair' will be open from 15 to 24 October, every day between 10am and 6pm. On Friday 15 October, opening day, the Biennale and therefore also 'theyoungdesignersfair' will remain open until 9pm.

12

Each participant is entitled to a free mention in the 'theyoungdesignersfair' section of the INTERIEUR 2010 catalogue, which will be published by the Interieur Foundation.

13

Participants are expected to insure their goods and materials against all possible risks. In no way can the Interieur Foundation be held responsible for any damage to persons or goods, be it the result of accident, rain, theft or fire, or any other cause. Participants and their personnel are responsible for any accidents or damage to the building, their own goods, or other participants and visitors, and their goods.

In signing the 'Application for selection' form, each candidate undertakes to adhere to all clauses of these regulations, and to adhere to all measures and instructions to be issued by the Foundation's committee at a later date. All participants are also expected to conform to all other legal requirements and regulations, regarding taxation, copyright, permits, etc.

15

Participants undertake not to disturb the general atmosphere of 'theyoungdesignersfair' with music, projection or any other form of expression which would extend beyond the boundaries of their own stand.

16

Should there be an infringement upon the regulations by any participant, the Interieur Foundation is entitled to put an end to it without delay. This may also involve immediate vacation of the stand, any costs to be charged to the participant involved. The Interieur Foundation reserves the right to remove persons, products or materials from the stands, should these not conform to the regulations.

17

Exceptions to all the above can only be allowed after permission in writing from the Interieur Foundation.

18

Should the Foundation decide that INTERIEUR 2010 cannot take place, because of economic condition, circumstances beyond their control or for any other reason, participants will not be entitled to any compensation.

19

In case of dispute, the Court of Kortrijk will be the sole arbitrator, and only the Dutch text of the regulations is legally valid.
